SPECIAL INSTRUCTIONS:

- 1. On the third day (October 6, 2016) Every candidate is required to bring to the examination room the following:
 - a. Drawing instruments: mechanical pencils (HB) 0.5, pencil eraser, T-square 36' long, metric scales, triangle 30°x60° and 45°x6''long, Flexible curve or ship curves, scientific calculator and masking tape.
 - b. any classification rule reference books: ABS Building and Classing Steel Barges, ABS Building and Classing Steel Vessel under 70m or 90m in length.
 - c. A3 paper/s will be furnished by the Board and other tables for guide. No books of similar titles, review materials and other examination aides will be allowed inside the examination building.
- 2. Use only <u>black ink</u> for the entire design examination. Using different color other than black is considered as <u>marked paper</u>.
- 3. Candidates will not be allowed to leave the examination rooms, borrow anything or communicate with one another on any subject matter. Every candidate is required to bring his/her lunch and/or supper (placed inside transparent/plastic bags) with him/her during the examination. No food of any kind carried by any person intended for any candidate during the progress of the examination shall be entertained by watchers or received by any candidate.
