DESIGNATION OF DAVAO CITY AS AN ADDITIONAL TESTING CENTER FOR THE JUNE 2016 BOARD LICENSURE EXAMINATION FOR ARCHITECTS (BLEA)

WHEREAS, Section 7 (d) of Republic Act. No. 8981, otherwise known as the PRC Modernization Act of 2000, provides that the Professional Regulation Commission (Commission) shall have the power to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate; determine and fix the places and dates of examinations; xxxxx;

WHEREAS, the Commission issued PRC Resolution No. 2015-948 prescribing the dates and venues for the professional licensure examinations for calendar year 2016, with the Board Licensure Examination for Architects (BLEA) scheduled on June 24 and 26, 2016 in the Cities of Manila, Baguio, Cebu and Legazpi;

WHEREAS, the Commission, thru its Regional Office in Davao, has received a request from the United Architects of the Philippines-Kadayawan Dabaw Chapter for the conduct of the June 2016 BLEA in Davao City;

WHEREAS, the PRC Davao Regional Office has recommended to the Commission the approval of the foregoing request for economic and other practical considerations, as stated in its letter dated March 02, 2016;

WHEREAS, in consideration of the more than fifty (50) examinees who have signified interest to take the June 2016 BLEA in Davao City, the Professional Regulatory Board of Architecture (Board) poses no objection to the approval of the request;

WHEREFORE, under these premises, it is hereby **RESOLVED** by the Board to designate Davao City as an additional testing center for the June 2016 BLEA, subject to the approval of the Commission;

FURTHER RESOLVED, that necessary coordination be undertaken by all involved offices/divisions of the Commission to ensure the smooth and orderly conduct of this licensure examination.

Let copies hereof be posted in the PRC official website and further furnished the Board, Office of the Board Secretary, Licensure Office, Examination Division, Application Division, and all Regional Offices for their information and guidance.
