Male Examinees - Plain white polo shirt with collar (without any seal, logo or mark)
Decent pants or slacks

Female Examinees - Plain white blouse or shirt with collar (without any seal, logo or mark)
Decent pants, slacks or skirt
4. **Bring the following on examination day:**
 - a. Notice of Admission
 - b. Applicant's Stub
 - c. Official Receipt
 - d. One (1) piece metered stamp window mailing envelope
 - e. Two (2) or more pencils (**No. 2**)

- f. Ball pens with **BLACK ink only**

 - h. One (1) piece long transparent/plastic envelope (for keeping your valuables and other allowed items)
